

Joint Letter: Building Canada with Renewable Electricity

Dear Prime Minister, Ministers

We write to you to urge you to prioritize funding for electricity transmission, renewable electricity, Indigenous and community ownership, and energy efficiency as key projects in the national interest.

Building out Canada's east-west electricity grid as part of a nation-building project with provinces, territories, Indigenous rights-holders and other stakeholders was a [key commitment of your party in election 2025](#). This is a strategic, timely effort that should be identified as a top priority. It is worthy of significant federal resources to invest in affordable, secure, renewable power that supports Canada's energy security. This project can bring significant jobs, health, affordability and national security benefits to communities and businesses throughout Canada.

Canada's electricity needs are projected to [double or even triple](#) before 2050, thanks to increasing electrification of industry, transportation and heating. Upgrading Canada's east-west transmission grids has been the topic of study by the [federal government](#), [interregional planning bodies](#), [expert advisory councils](#) and leading [energy modelling initiatives](#) for over a decade in Canada, and enjoys broad support from [business](#), [labour](#), [Indigenous](#) and [environment](#) groups.

Improving the flow of electricity via new or upgraded transmission connections between provinces has been shown many times to save ratepayers money and increase system reliability. It's also a foundational requirement for the clean electrification of Canada's economy more broadly. This comes with opportunities to build on the [existing leadership of Indigenous Nations in renewable electricity projects](#), and with the responsibility to [uphold Indigenous rights and Indigenous energy sovereignty](#). The shift toward renewable electricity also comes with significant reductions in air pollution and [savings](#) from avoided health system costs. However, attempts to better connect Canada's electricity system are beset by permitting and funding challenges, as well as [interprovincial trade barriers](#). Federal government leadership is clearly needed.

Canada faces threats from the current administration in the United States, and significant economic uncertainty. Better integrating Canada's electricity system is crucially important for energy security and economic competitiveness in the near term, but it is also a no-regret investment for the long-term prosperity of everyone living in Canada. Grid upgrades at this scale could create more than [300,000 jobs by 2050](#). These projects can facilitate clean economic growth in key sectors and, if materials are procured here in Canada, can also bolster sectors currently under attack by U.S. tariffs, such as aluminum and steel.

Consolidating and expanding these gains and opportunities requires a better east-west grid, and require key actions and commitments by this federal government in the near term, including these priorities:

- Commit significant federal funding toward permitting, planning and construction of **strategic interprovincial and intra-provincial electricity transmission projects**. In addition to project funding commitments, the federal government has a key role to play in resourcing and convening provinces, territories, Indigenous nations, utilities, proponents and other key stakeholders to ensure project success.

- The [Green Budget Coalition](#), [Green Economy Network](#) and [Climate Action Network Canada](#) each identify a funding commitment of at least \$20 billion over five years, beginning in Budget 2025, as an appropriate first step toward federal support for a pan-Canadian electricity network, while the [Canada Electricity Advisory Council](#) recommends significant investment and reducing barriers for these transmission projects.
- Uphold legal and inherent **Indigenous rights** for Indigenous communities throughout Canada. This includes recognizing **Indigenous Nations' leadership role in renewable electricity in Canada**, expanding support for Indigenous-owned and Indigenous-led electricity projects and upholding Canada's highest standards and responsibilities under the United Nations Declaration of the Rights of Indigenous Peoples, and in upholding Indigenous Free, Prior, and Informed Consent.
- Implement **key labour supports** as a condition for federal funding on electricity projects, including prevailing wage requirements, training capacity and other just transition priorities. This support should prioritize unionized work and include support for youth, newcomers, Indigenous communities and other equity-deserving groups that are underrepresented in the skilled trades.
- Alongside the work on transmission and generation, the federal government should strengthen its financial support for **energy efficiency, demand-side management, energy storage and other electricity system upgrades** in line with delivering affordable, reliable, clean electricity to everyone living in Canada.
- With these priorities in mind, your government should update and implement **Canada's Electricity Strategy**. This includes implementing the Clean Electricity Regulations, and continuing to advance Canada's work to achieve a net-zero electricity grid.
